## 6. Annual Playground Inspection

Three quotations had been obtained and were discussed. It was agreed to recommend appointment of The Play Inspection Co Ltd as their quote was the cheapest at £59.95 plus VAT. Item to be passed to the PC for approval.

#### 7. Football

£40 cash had been given to the Clerk as match fees from Marshland Saints.

Mr. Gowler advised that Marshland Saints had made a good start to the season as they had played three matches and won all three. A new manager had been appointed for the under 6 team; in December he would complete his level 1 coaching and they would be able to go for charter standard. England's Hope had played one match. Cllr Norman advised that he had left a note for the England's Hope team to advise them that they had left the lights and one of the showers on in the pavilion and to point out to them that the wheel should come out of the marker.

Cllr Gathercole advised that the hedge and ditch had been cut by the Drainage Board. Cllr Norman advised that the Bowls Club had completed the season and finished in a similar position to other years.
