7. Playing Field

- Quotations were being sourced for a new gate from the hedge to the play area.
- The dyke at the front was now clear of water and therefore it was the perfect time to get the mud blasted out from the culvert. The company who carried out the work a few months ago was no longer in business. Cllr Boyce to provide contact details to the Clerk for another contractor.
- Signs for the barriers had been ordered.
- Anglian Water to complete sewerage connection for the Hall over the next week and they would be resurfacing the PC car park area the following week.
- New posts had now been installed between the Hall and the play area.
- South side entrance barrier and goal posts had been painted.
- Gates to Bowls Green to be painted shortly.

8. Community Notice Board

Three quotations had been obtained for a notice board; the quotations were discussed. To purchase a notice board from Earth Anchors for £598 plus VAT with funding from the Community Infrastructure Levy income.

13. Highways issues

Chapel Lane & Bonnetts Lane – pot holes had been repaired

Smeeth Road – trod between No 70 and No 80 had been repaired by the Rangers New issues to report:

Hickathrift Field – street name sign obscured by overhanging hedge.

Walton Road (No 15) - foundations exposed around street light.

Pumping Station Bungalow – overhanging hedging needs trimming back.

Wheatsheaf Forge – overhanging hedging needs trimming back.

Smeeth Road/Trinity Road junction – Anglian Water cover had disappeared.

Trinity Road (No 33) – static caravan had been installed.

Hungate Road up to playing field (Emneth) – pot holes.

Smeeth Road/Walton Road junction - pot holes and loose drain cover.

Lots of properties currently had overhanging hedges - put general notice in Marshland Messenger to ask residents to trim.
