7. Playing Field Management Partnership (PFMP)

The PFMP had asked the PC to approve submitting a grant application to the Mick George Community Fund for £50k to help with the cost of the project to replace the skate ramp and refurbish the MUGA. The PC would need to supply 11% of any funding approved as a condition of the grant award; which was usual practice for this type of funding. Other smaller grants could be available and this would also be explored. An update on quotations and ways of funding the project was provided by the Clerk.

Rustons Road & Moyses Bank – new street name plates had been installed. New issues to report:

St Paul's Road South (near Mill House) - wooden posts installed on highway

Smeeth Road – request for signs warning of horse riders on road

Middle Drove (near Fir Tree Farm) – pot hole

Chapel Road/School Road junction - pot hole

Smeeth Road (opposite the Bowls Green) – damage to footpath

Smeeth Road – white blocks too close to the road at one property

Concerns were raised about speeding motorists in the village and a discussion took place on setting up a Community Speed Watch Scheme and the possibility of asking Highways to consider reducing the speed limit to 30mph.

Action: Clerk to contact West Walton PC on first new issue and report other issues to Highways.
